

Rules and Regulations.

1. ALL ANGLERS MUST BE IN POSSESSION OF A CURRENT ENVIRONMENTAL AGENCY LICENCE.
2. The bag limit is **SIX FISH** for any day or season permit holder. **ONLY TWO BROWNS** out of a SIX BAG LIMIT.
3. Permits shall be purchased in advance. No angler shall enter the fishing area without first obtaining a permit. A permit shall not be transferred and shall be produced on request to any authorised officer or servant of the Association or to any other angler who produces his own permit.
4. CATCH & RELEASE UNTIL THE LIMIT OF 6 FISH HAVE BEEN DESPATCHED, THEN FISHING MUST CEASE, UNTIL ANOTHER PERMIT IS PURCHASED. THE USE OF BOOBIES FOR C&R IS PROHIBITED, AND THE USE OF BARBLESS HOOKS IS STRONGLY RECOMMENDED.
5. The fishing season shall be as stipulated for trout by the Association.
6. No trout measuring less than ten inches shall be retained. All fish to be returned to the water shall be handled gently and carefully.
7. Fishing shall not commence earlier than ½ hour before sunrise and shall not continue later than 1 hour after sunset.
8. Flyfishing only shall be permitted. The carrying and use of any equipment other than a fly rod and a fly reel is prohibited. The carrying and use of ground baiting, maggots, worms, floats, including bubble floats and fixed spool reels is prohibited.
9. Permit holders shall render returns of fish taken in accordance with the instructions on the return forms.
10. Boat fishing allowed only from boats hired from the Association.
11. The association, through its officers and servants, shall be empowered to cancel a permit and/or to refuse the issue of a permit to any person without question. The person so treated shall have the right to appeal against the cancellation and/or the refusal to the Management Committee of the Association.
12. Anglers and those accompanying them shall at all times behave in a way that will not cause a nuisance, damage to property, or inconvenience to other users of the amenities of Llyn Clywedog. In particular :
 - * No act which may result in the fouling of the fishing area or of the water in or flowing into the reservoir shall be committed;
 - * Juveniles under 12 years of age who receive a free permit and those between 12 and 16 years of age who receive a reduced price permit are limited to 3 fish per day. (Only 1 Brown).
In the interest of SAFETY they must ALWAYS be accompanied by an adult.
 - * Fishing and other activities connected with it shall not interfere with any other activities including maintenance work, sailing, and other sporting activities being carried on upon or near Llyn Clywedog by the Authority or by authorised third parties;
 - * No person shall interfere in any way with the wild birds or their nests; and care should be taken not to throw nylon waste about in the open;
 - * No person shall interfere in any way with the machinery, drains or any arrangement cages of the undertaking for or in connection with the water supply nor in any way pollute or throw any detrimental substance into the waters of the reservoir or streams or damage any of the fences or other works belonging to the Authority or leave rubbish on the land adjoining the reservoir or works nor trespass on any part reserved by the Authority as private;
 - * Anglers shall not throw or deposit litter. Nylon waste is especially mentioned in this prohibition;
 - * Portable radio sets or other noise making instruments shall not be used.
13. Vehicle shall be parked in the area or areas designated for the purpose. Access to the bank shall be restricted to paths and/or approaches marked for access.
14. Trolling from boats is strictly forbidden.
15. Anglers fishing in Llyn Clywedog do so entirely at their own risk. The Association accepts no responsibility for any accident of injury to any angler or person accompanying him whether fishing from the bank or from a boat, or for any loss or damage to property which may be sustained or caused. It is advisable that all anglers whether bank (especially if wading) or boat fishing wear lifejackets.
16. No angler should fish with more than one fly rod at a time with this permit.
